

# PARISH NOTICE

## Connétables de Jersey

Trading on Sundays 24 November  
and 1, 8, 15, 22 and 29 December 2019

Sundays 24 November and 1, 8, 15, 22 and 29 December 2019 are designated as special occasions (see the Shops (Regulation of Opening) (Special Occasions) (Jersey) Order 2015). This notice is to advise that the Connétable of each parish has issued a blanket permit for certain shops situated in that Parish to open as specified below.

It is a condition of a blanket permit that where a shop is one that is open on weekdays as well as on a Sunday, the commercial activities that are carried on at the shop pursuant to the permit shall be substantially the same as those carried on at the shop on weekdays.

Additional conditions may also be imposed and are set out below.

### **Paroisse de St Brélade**

Subject to the condition shown above all shops with a retail sales area which does not exceed 700 square metres may open on any of the six Sundays.

Subject to the condition shown above and to the following conditions all shops with a retail sales area which exceeds 700 square metres may open on any of the six Sundays:

- a) Operating hours will be from 07.00 until 19.30.
- b) Opening hours will be from 09.00 until 18.00.
- c) Retail / wholesale deliveries other than newspaper deliveries will not be permitted.
- d) Traffic management arrangements must be agreed with the Parish at least 14 days prior to the opening Sunday.

### **Paroisse de St Héliér**

### **Paroisse de St Sauveur**

Subject to the condition shown above and to the following conditions supermarkets with a retail sales area which exceeds 700 square metres may open on any of the six Sundays:

- a) Operating hours will be from 7.00 until 19.00
- b) Opening hours will be from 9.00 until 18.00.
- c) Retail/wholesale deliveries other than newspaper deliveries will not be permitted.
- d) Traffic management arrangements must be agreed with the Parish at least 14 days prior to the opening Sunday.
