Request

As of 11 January 2019 please list all roads in the parish of St Saviour that do not have glass bins emptied by the parish from personal households and under what authority and whose instruction were these changes introduced.

For each Road listed please advise when householders were informed of the change to the previous monthly collection service, when the effective date was to be and also how the changes were communicated. Please also provide a copy of the communication(s) sent to the impacted households.

Response

As of 11 January 2019 all roads in the Parish of St Saviour have glass collected by the Parish. On some estates the collection is from a Eurobin rather than individual households – these estates are:

- Bashfords Estate
- Clos de la Molleterie
- Clos Gosset
- Clos Paumelle
- Grasett Park
- Le Geyt Estate
- Les Cinq Chenes
- Pre de Talbot
- Spencer Close
- Troy Court
- Wellington Park Estate

Clos Paumelle residents received notification from the Parish in October 2018 that the glass collection would change from 1 November 2018. A copy of the notification is below.

The reasons for the change, as explained in the notification, are the Growth, Housing and Environment Department guidelines on how to dispose of glass in a sustainable way and the Health and Safety of colleagues. Parking issues on this estate also limit the safe manoeuvring of the refuse vehicles and have affected the household collection service.

The other estates are administered by Andium Homes. From mid-2018, and after consultation between Andium Homes and the Parish, Eurobins were introduced on each estate. Notices were erected by Andium Homes at the bin bays on those estates but the Parish does not hold information on when or how householders were informed of the change (see below for FOI requests to Andium Homes).

Eurobins have been introduced in these areas having regard to the total tonnage of glass collected and Health and Safety considerations for Parish staff; the use of Eurobins means there is no manual handling involved.

The Parish keeps under review the services provided with the aim to reintroduce the household glass collection service once improvements have been made to the vicinities; we are also looking to pilot other schemes that may be beneficial to residents such as kerbside recycling.

Dear Occupier,

The Growth, Housing and Environment Department has recently issued Island wide guidelines as to how to dispose of glass products in a sustainable way. Taking this into consideration, as well as the Health and Safety of our colleagues, **from 1st November 2018** the Parish will no longer be carrying out monthly house to house glass collections.

Instead we ask that you put your “clean” glass in the euro bin which has been placed at the exit of your estate. Please see details below to what is deemed “clean” and “non-clean” glass. Please ensure that you **only place clean glass in the euro-bin.**

I apologise in advance for any inconvenience this may cause however your co-operation in complying with this new system will be greatly appreciated.
