**PARISH ASSEMBLY**

Minutes of an Assembly of Principals and Electors of the Parish of St Brelade held at the Parish Hall, St Aubin, St Brelade on Tuesday 17 February 2015 commencing at 19.00 hours.

**1. Minutes of  
Previous  
Assembly:**

The minutes of the previous Assembly of Principals and Electors of the Parish of St Brelade held on Tuesday 23 December 2014, were adopted, and signed, following a proposition by Mr Richard Haycock which was seconded by Centenier George May.

**2. Election of  
Officier du  
Connetable**

The Connétable called for nominations to fill the position of Officier du Connétable for the Vingtaine du Coin for a term of three years.

Centenier Susan Fox proposed Mr Jonathon Philip Breakspear to be elected to the position. This nomination was seconded by Mr Peter Sowa.

There were no other nominations.

The Connétable declared Mr Breakspear elected as Officier du Connétable for the Vingtaine du Coin for a term of three years. The Connétable congratulated Mr Breakspear and advised that the date to appear before the Royal Court of Jersey to take the Oath of Office was Friday 27 February 2015 at 10.00 hours.

**3. Election of  
Cimetiere des  
Quennevais  
Committee  
members**

The Connétable called for nominations from electors of the parish to serve on the Cimetiere des Quennevais Committee for a term of three years. Two positions being vacant.

The following persons were nominated:

There were no other nominations.

The Connétable congratulated and declared Mr Corbin and Mr Bellows elected as members of the Cimetiere des Quennevais Committee for a term of three years.

**4. Licensing:**

In accordance with Article 5 (1) of the Licensing (Jersey) Law, 1974, as amended, the following application was considered for recommendation to the Licensing Assembly:

<b>Business Address:</b>	Murray's La Neuve Route St Brelade

The Connétable then asked for the representative of Anatole Enterprises Limited to talk about the proposal.

Advocate Simon Young of Bois Bois explained that the application was for a basic transfer of the current licence to new ownership as the current owner being Murray Norton is now a member of the States. The company Anatole Enterprises Limited has been established since 1995 and owns Eulah Country House. The premises Murray's will remain the same in name, staff and food, being literally a transfer of licence.

The Connétable asked if there were any questions from the floor.

Centenier Michel Bougeard asked if the opening hours were to remain the same. Advocate Young replied that as far as he was aware they would remain the same.

The Connétable then read excerpts from the reports obtained as required by Law. Environmental Health commented that the condition of the premises was satisfactory for the transfer of a licence and that the sanitary accommodation is sufficient for 60 persons. The Fire Service mentioned that servicing of lighting and exit signs was required, they also stated that if planned refurbishment was not started from 6 months from the date of their report then a suppression system will be required above the cooking range. They also stated that occupation of 60 persons was acceptable. N V Bate Associates, Structural Engineers commented that although there was background music playing in the café it was not enough to be of nuisance to the occupant of the flat above or premises to either side of the building and that the business has been operating successfully for a number of

years and therefore should not cause a nuisance to the surrounding area.

There were no further questions.

Recommendation of the application to the Licensing Assembly was proposed by Deputy Murray Norton and was seconded by Mrs Anna Norton. Following a vote by a show of hands the item was supported by 17 votes in favour with 0 votes against.

The Connétable advised the Assembly that the Licensing Bench was to be held on the 19 March 2015, and that only persons who asked questions at the Parish Assembly were permitted to speak at the Licensing Bench Assembly.

In thanking the remaining 19 persons for their attendance the Connétable declared the meeting closed at 19.20 hours.
