**ASSEMBLY OF ELECTORS**

Minutes of an Assembly of Electors of the Parish of St Brelade held at the Parish Hall, St Aubin, St Brelade on Wednesday 11 April 2018 at 19.00 hours in pursuant to an Act of the Royal Court dated 23 March 2018 and in conformity with Article 19 of the Public Elections (Jersey) Law, 2002. The Assembly was held to elect one person to the office of Connétable.

**President of Assembly:**

In accordance with Article 20 (2) of the Public Elections (Jersey) Law Mr Peter John Norman, Procureur du Bien Public, welcomed those present and stated that in view of the Connétable being a candidate in the Senatorial Elections he is not permitted to preside over the Assembly; therefore Mr Norman would preside.

**Convening Notice:**

The Convening Notice was read by the Parish Secretary.

**Election of Connétable:**

The President called for nominations to fill the position of Connétable for the next three years.

The nomination document was checked against the Electoral Register produced at midday on Monday 9 April 2018 and found to be in order.

As there were no other nominations and the time required by law having passed, the President announced that in view of there being more than one candidate a Poll of Electors will be held on Wednesday 16 May 2018 to proceed with the election of one Connétable. The polling stations will be at the Parish Hall and Communicare Centre, St Brelade with the stations being opened between the hours of 08.00 hours and 20.00 hours. The count will take place at Communicare.

The President of the Assembly announced that the number of electors on the Electoral Register is 7577.

The President mentioned how persons who will be out of the Island on polling day may apply for a postal vote and persons, who wish to cast their vote before polling day, may do so by using the pre poll facility at St Paul's Centre during 30 April 2018 and 14 May 2018. The President also advised on the election expenses which can be claimed by a Candidate and that guidelines have been issued by the States of Jersey Department for Infrastructure regarding placing and removing of election material.

No protests were made and all formalities required by the law were observed.

The candidates duly thanked their proposer and seconders.

The President of the Assembly declared the Assembly closed at 19.16 hours.
