PARISH ASSEMBLY

An Assembly of the Principals and Electors of the Parish of St Clément was held at the Parish Hall on Tuesday 16 December 2014 at 7.00 pm to:

1. Elect a Vingtenier for the Vingtaine de Samares
2. Elect Constable's Officers for the Grande Vingtaine
3. In conformity with Article 5 of the "Loi [1914] sur la Voirie, elect three Principals residing in the Parish as members of the Roads Committee for a three-year period with effect from 1 January 2015
4. In conformity with Article 5 of the "Loi [1914] sur la Voirie", elect two Roads Inspectors for each of the Vingtaines of Samares, Roquier and Grande for a three-year period with effect from 1 January 2015
5. In conformity with Article 32 of the Rates (Jersey) Law, 2005, to elect as a member of the Assessment Committee with effect from 1 January 2015, one person to serve a three-year period; the term of office of Mr Trevor Le Sueur being due to expire on 31 December 2014


