Having declared Vingtenier Brookfield duly re-elected the Connétable thanked her for her years of service, complimenting her on her reliability and dedication. The Connétable then informed the Assembly that Vingtenier Brookfield was first sworn to the Honorary Police on 18th March 2005 as a Constables Officer for the Vingtaine Haut de la Vallée, being re-sworn as Constables Officer on 28th March 2008. On the 27th November 2009 she was sworn as Vingtenier for the Vingtaine Coin Hatain and was re-sworn on 30th November 2012. This will be her third term of office as Vingtenier. The Connétable warned Vingtenier Brookfield to appear before the Royal Court on Friday 27th November 2015 at 10am to take the customary Oath of Office.</p>
