Minutes of Parish Assembly

1. Receive and if deemed advisable approve the Minutes of the Parish Assembly held on 12 November 2014.

The Connétable advised all present that copies of the Minutes had been available at the Parish Office and copies were available at the meeting.

The Minutes of 12th November 2014 were taken as read and approved, proposed by Deputy J Le Fondré and seconded by Deputy E Noel.

On a vote all were in favour, none against.

2. In conformity with Article 32 of the Rates (Jersey) Law 2005, to elect two persons to act as members of the Rate Assessment Committee, for a period of three years, the term of office of Mr Sean Morvan and Mr Matthew Chambers due to expire.

The Connétable warned Messrs Morvan and Ross-Gower to appear before the Royal Court on Friday 19th December 2014 at 10am to take the customary Oath of Office. She thanked the Rate Assessment Committee for their hard work during the year.

3. To elect a Vingtenier for Vingtaine Haut de la Vallée, the term of office of Bruce Thomas due to expire.

- Vingtenier Thomas was nominated by:
- Proposer: Mrs M Hibbeard. Seconder: Mr D Mezbourian.

On a vote all were in favour, none against.

The Connétable warned Vingtenier Thomas to appear before the Royal Court on Friday 19th December 2014 at 10am to take the customary Oath of Office. She thanked him for allowing his name to be put forward to serve for another term of

The Connétable then thanked all Parishioners and staff for their contribution to Parish life throughout 2014 and wished them season's greetings and a prosperous New Year.
