- 3 Elect a Roads Inspector for Vingtaine Coin Varin, to complete the term of office of the previous holder as they no longer live in the Parish.
- 4 Elect a member of the Rates Assessment Committee, for a period of three years, the term of office due to expire.
- 5 Elect a Chairperson for St Peters Youth & Community Centre, for a period of three years, the term of office due to expire.
- 6 Elect a Treasurer for St Peters Youth & Community Centre, for a period of three years, the term of office having expired.
- 7 Elect an Officers du Connetable for Vingtaine St Nicolas, for a period of three years, the term of office due to expire.

Apologises were given that the Constable, Richard Vibert was held up in a states assembly and therefore the senior Procureur Chris Benest held the assembly.

Apologises also given for Father Michael who was also unable to attend due to a prior zoom meeting.

- 1 On the proposition of **Joao Camara**, seconded by **Susan Morin**, the minutes of the previous assembly held on Tuesday 7 July 2020, which had been previously unapproved but were handed out were approved.
- 2 On the proposition of **Francis "Guy"Le Maistre**, seconded by **Robert Surcouf**, the minutes of the previous assembly held on Tuesday 28 July 2020, which had been previously handed out were approved.

- 3 **Peter Lamy** was nominated for the position of Roads Inspector for Vingtaine Coin Varin, he was proposed by **Keith Capern** and seconded by **Robert Surcouf**. Peter had previously held positions in the parish as a member of the roads committee and a Constables officer in the honorary police and is willing to offer his services to the parish again to complete the term of the previous holder.
